Meeting of George Nympton Parish Council 17th January 2019

Minutes of the Meeting

Councillors Present-Roger Gay (Chair), Jon Ride, Trudy Herniman, Mark Dean, Trevor Allen, Richard Toller.

2019/001-Apologies/Attendance Register-Apologies were received from Adele Poole who was unwell.

2019/002-Disclosable Pecuniary Interests-There were none.

2019/003-Announcements from the Chair-Roger Gay informed the meeting that Andy Warren has resigned from the Council because he is unable to commit the time required. The Council thanked Andy for his service.

Roger reminded the Council that the local elections will be held on May 2nd.

2019/004-Minutes of the Previous Meeting-The minutes of the previous meeting were unanimously agreed and signed by the Chair.

2019/005-Democratic 15 Minutes/Public Question Time-Ian Bateman asked a question about the Parish Council's Website. It was agreed that the website's community pages should be updated on a regular basis in order to provide fresh information on community activities, including The Village Hall and Church. Jon Ride agreed to look at the website and to be involved in regular updating. It was agreed to make this a regular item for the agenda.

2019/006-Dispensation Requests-There were none.

2019/007-Planning Matters-Planning application reference number 65906. Erection of garage and secure store at Riverview, George Nympton, Ex36 4JE. The Council voted unanimously in favour of the application.

2019/008-County Councillor's Slot-Jeremy Yabsley attended the meeting and provided an update. He answered Richard Toller's questions on potential grant applications.

2019/009-District Councillor's Slot-Eric ley attended the meeting and provided an update.

2019/010-Financial Matters-Richard Toller informed the meeting that he is awaiting authorisation from the bank to access the accounts online. There has been no movement of money since the last meeting.

He has completed the parish precept paperwork and is looking at available grants for further works to the village hall.
