#### Minutes of the meeting

**2019/023-Apologies/Attendance Register**-Apologies received from Trudy Herniman who had work commitments.

**2019/024-Disclosable Pecuniary Interests**-There were none.

**2019/025-Announcements from the Chair**-Roger Gay informed the meeting that Meethe Road would soon be closing for up to three weeks for works by South West Water.

**2019/026-Minutes of Previous Meeting**-The minutes of the previous meeting were unanimously approved and signed.

#### **2019/027-Democratic 15 Minutes/Public Question Time.**

Kevin Harvey gave a description of the planning application 66264.

Mark Dean described the ongoing works at his property. Planning permission granted.

**2019/028-Dispensation Requests**-There were none.

#### **2019/029-Planning Matters.**

2019/029.1 Ref 66312. Extension to dwelling at North Woodhouse, Queen's Nympton. Council voted unanimously in favour of the application.

2019/029.2 Ref 66264-Demolition of one dwelling and one agricultural building. Erection of one dwelling and one agricultural building. Temporary siting of one static caravan & one storage shed at New House, Queen's Nympton. The Council voted unanimously in favour of the application.
