2022/001-Apologies/Attendance Register-Apologies were received from Trudy Herniman who had another commitment.

2022/003-Minutes of Previous Meeting-The minutes of the previous meeting were unanimously approved and signed by Jon Ride.

2020/004-Announcements from the Chair-Jon Ride welcomed Sue and Tom who have recently moved to the village and thanked them for attending the meeting.

Jon asked the meeting to consider including planning applications 74607 & 74626 in this meeting. The Councillors unanimously agreed to include under agenda item 2022/010.

2020/010-Planning Matters.

2020/010.1 Planning Application reference 74599. Construction of a new dung store at Parsonage Farm, George Nympton, EX36 4JD.

The Council unanimously voted in favour of the application.

2020/010.2-Planning Application reference 74607. Variations of conditions 2 (approved plans) & 5 (transport plan) attached to planning permission 60841 to allow an additional 9500 tons of crop

feedstock to be imported from neighbouring farms at Great Hele Barton Farm AD Plant, Great Hele Lane, South Molton, EX36 4LB.

The Council discussed the application and agreed to submit comments on the planning portal. Jon Ride to circulate a draft of the Council's response for approval before closing date of February 7th.

2020/010.2-Planning Application reference 74626. Variations of conditions 2 (approved plans) and 4 (transport plan) attached to planning permission 60842 (relocation of approved infrastructure & construction of additional at the anaerobic digestion plant) to allow an additional 9500 tons of crop feedstock to be imported from neighbouring farms into the AD plant- used to create additional renewable energy at Great Hele Barton Farm AD Plant, Great Hele Lane, South Molton, EX36 4LB.

The Council discussed the application and agreed to submit comments on the planning portal. Jon Ride to circulate a draft of the Council's response for approval prior to the closing date of February 7th.

2020/011-Village Hall-Adele Poole provided an update. The refurbishment of the bar area is complete and the new windows and doors have been fitted. The next planned project is a porch & ramp at the front entrance. Adele is looking at fund sourcing and several fundraising/ social events are planned from February onwards.
