2025/023 & 032 - Democratic 15 Minutes/Public Question Time and update on issues with hunt:

Following the approach to the Parish Council by concerned residents regarding the abusive and antisocial behaviour and reckless driving of quad bikes of hunt followers going through the village, members of the council have had a meeting with senior members of Tiverton Staghounds.

The organisation has a code of conduct regarding behaviour on a hunt and this is reiterated in person at the start of a hunt to all participants and followers. They are aware that any anti-social behaviour damages their reputation and seek to do whatever they can to prevent this. They are planning to ensure that those following on quad bikes are registered by colour and registration plate by the Staghounds.

They are prepared to ban followers where they can be identified by this method. If these details can be provided as evidence of those behaving abusively/dangerously, the Council now has a contact to forward them to. Without evidence they can't take action and there will be quad bike riders who are unknown to them.

With regard to legal recourse, quad bikes that are being driven on the road must be approved, registered, taxed and MOT'd if required and the driver must have a driving licence and insurance. They can be prosecuted if driving dangerously or carelessly, or on a footpath or land where they don't have permission. In order for reckless or abusive behaviour to be addressed by the police, it will need to be reported to the police as a crime and this again will need evidence. This will also apply should further action be sought, such as through a Community Protection Notice.

In summary, Tiverton Staghounds will take action if the individuals can be identified and if evidence can be provided, plus the behaviour can be reported to the police as a crime.

However, the public attending again requested that the Council declare George Nympton as a 'hunt free zone' and the Council will further consider this.
